Personal data that we process

SuzesMore processes your personal data because you use our services and/or because you provide it to us yourself.

Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years of age. Unless they have parental or guardian permission. For what purpose and on what basis we process personal data

- Offer you the option to create an account
- To deliver goods and services to you
- SuzesMore also processes personal data if we are legally obliged to do so, such as data that we need for our tax return.

Automated decision making

SuzesMore only uses the cookies that wix itself offers and automatically uses to build the website. SuzesMore does not use any

information obtained from the cookies. The data is also not passed on to third parties. This concerns decisions that are taken by computer programs or systems, without involving a person (for example a SuzesMore employee). SuzesMore uses the following computer programs or systems: Wix

How long we keep personal data

SuzesMore does not store your personal data for longer than is strictly necessary to realize the purposes for which your data is collected. We use the following retention periods for the following (categories) of personal data:

Orders: Until when completed.

Registration details: Until canceled

Sharing personal data with third parties

SuzesMore does not sell your data to third parties and only provides it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. We conclude a processor agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. SuzesMore remains responsible for these processing operations. We only provide data to postal companies to send your packages.

Cookies, or similar techniques, that we use

SuzesMore only uses technical and functional cookies. And analytical cookies that do not infringe on your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferred settings. We can also optimize our website with this. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via the settings of your browser. You can refuse all cookies.

View, modify or delete data

You have the right to view, correct or delete your personal data. You can do this yourself via the personal settings of your account. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by our company and you have the right to data portability. This means that you can submit a request to us to send the personal data we have about you in a computer file to you or another organization mentioned by you.

If you would like to exercise your right to object and/or right to data portability or if you have other questions/comments about data processing, please send a specified request to suzesmore@outlook.com.

To ensure that the request for access has been made by you, we ask you to enclose a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. SuzesMore will respond to your request as soon as possible, but in any case within four weeks.
